



- Staff will notify the committee when the agenda has been posted











WSC ER: Design Activity Update


- 65% Design Review Complete
 - Working towards 90% Design
 - Revise design based on review comments
- Response for Betterments/Additional Work
 - Pending USACE approval

WSC ER: Design Activity Update

- Martinez Trail Extension to Farias Park
 - Design in progress based on USACE feedback
 - Most recommendations will be included as additional work/betterments (once approved)

90% Public Sessions targeted late Spring 2025


