


Project Status Update

Rebecca Krug, River Authority




- Working towards 90% Design
 - Revise design based on 65% review comments
 - Schedule and budget evaluation for full restoration on Martinez
 - USACE PM Change Andrew Park
- Response for Betterments/ Additional Work
 - Approved!
 - Conditional based on design
 - Next steps amend scope and budget





- Martinez Trail Extension to Farias Park
 - Design of trail and street connections in progress
 - Reviewing retaining wall aesthetics and other furnishings
 - Trailheads and pedestrian bridge can be included as additional work/betterments







- Real Estate Acquisitions
 - TxDOT title research in progress
 - SAISD survey in progress, appraisal next
 - Opportunity Home survey soon, then appraisal
- Construction and Staging Access
 - Design team is reviewing locations for construction





- Utility Relocations
 - SAWS coordination Alazan sanitary/water lines

- Baseline Aquatic Surveys
 - In the news: Guadalupe Bass found in Southern reach of San Pedro Creek


Rare fish found in San Antonio's San Pedro Creek

WSC ER: Schedule Update


- 90% Public Sessions targeted late Spring 2025, TBD

 - 20+ attended pre-bid meeting
 - Bids due 3/6
- Construction Summer 2025
- Local project complete before start of Apache ecosystem restoration






River Authority's Supplemental Oral History Project

- River Authority has received positive responses to initial contact regarding interest in contributing to the project
- Invitations to schedule interviews will be sent out this week
- Interviews will begin next week
 - Availability on Monday Friday
 - February availability 9:00 4:00 PM
 - March availability depends on weekday
 - Guadalupe Cultural Arts Center, Promesa Building
- There is a public form available on the project website where residents can request an interview or write in with their contributions if they are not interested in interviewing



San Pedro Creek Culture Park

- Completion of the new railroad
- Successful demolition and construction of new bridge within 74 hours
- The project is on target to finish construction this Spring

- Project in design
 - 95% Design milestone est. May

- Local Apache Creek Remediation project
 - Construction begins in May
 - Pre-construction public meetings
- Discussion on potential COSA 2027 Bond projects
 - Thoughts on recreation opportunities, improvements to parks on the Westside, stormwater drainage infrastructure, etc.



2025 Calendar: July - September

- Project in Design, end stages
 - 100% Design milestone est. August-September
- USACE Items
 - Following completion of design, begin real estate certification
- Mid-year update on supplemental oral history effort
- Mid-year update on federal funding
- Local Apache Creek Remediation project
 - Under construction



2025 Calendar: October - December

- Preparing for construction procurement
- USACE Items
 - Real estate certification with HQ
- Update on federal funding
- Update on 1043(b) application
- Local Apache Creek Remediation project
 - Construction completion est. December



Water Resources Development Act

- On Saturday, January 4th, WRDA was signed into law
- The project will proceed with the full restoration of Martinez Creek
- Press conference on January 10th
 - Attended by elected officials and local community members
 - Press coverage
 - Thank you to the committee members who attended to celebrate this milestone





Continued Lobbying Efforts

- River Authority board members and staff will continue advocating for the project at a local and federal level
- Washington DC February
 - River Authority staff traveled to DC earlier this month to discuss the implementation of Alternative 7 (Martinez Creek) and the 1043(b) application
 - Meetings with USACE, OMB, and members of the federal delegation
- Washington DC March
 - River Authority board members and staff will travel to DC as part of the SA to DC program
 - Currently requesting meetings with USACE HQ, members of the federal delegation
 - Monitoring appointment of a new Assistant Secretary of the Army, Civil Works
